Enrollment is now open for the 2020 Santee Lakes Approved Vendor List!



This is an opportunity for local businesses to provide their services in the Park for events or visitor needs. Santee Lakes requires guests/campers to utilize vendors on our Approved Vendor List to conduct business in the Park such as catering, inflatables, food delivery, and/or RV repair. Santee Lakes has 300 RV spaces, 10 cabins, and 26 picnic/event areas that are reserved the majority of the year.

New this year, we are offering a Campground Only Vendor option which is perfect for mobile repair, dog groomers, or food delivery services.

We currently offer three vendor opportunities: Premium Vendor, Preferred Vendor, and Campground Only Vendor.

Premium Vendor | \$300 Annual Registration Fee

- Your business will be listed on our Premium Vendor list given to customers making reservations
- Your business will be promoted via our social media platforms to over 17,000 followers
- Your business will be promoted via our website at www.santeelakes.com which registers over 300,000 views annually

Preferred Vendor | \$100 Annual Registration Fee

- Your business will be listed on our Preferred Vendor list given to customers making reservations for events

Campground Only Vendor | \$75 Annual Registration Fee

- Your business will be listed on our Campground Only Vendor page on the website

To Apply*:

- Review and complete the Vendor Application. Incomplete applications will not be accepted.
- Please provide **proof of insurance**: \$1 million per occurrence/ \$2 million aggregate General Liability (GL) with **Padre Dam MWD, 9300 Fanita Pkwy, Santee CA 92071** listed as additional insured. A separate additional insured endorsement page is required as well.
- Please include a copy of your **City of Santee business license** with the **completed application**.
- Once approved, the annual registration fee is due.

*Filling out the application does not guarantee approval (see the attached District Rules and Regulations for more details). Applications will be reviewed and must be approved by Santee Lakes. If approved, the permit will be effective on the date of issuance and is valid for the duration of the calendar year, expiring December 31. Vendors and their employees entering Santee Lakes are subject to the Day-Use Vehicle Parking fees. Trailers and extra vehicles are subject to the Day-Use Parking fee, as well. Refer to the section regarding fees and charges for current Day-Use Vehicle Parking fees. Vendors will relinquish their vendor status if they do not appear for the reserved event without a 72 hour notice. These vendors can re-apply as an Approved Vendor, subject to Staff discretion.

ANY VENDOR NOT ON THE PREMIUM, PREFERRED, OR CAMPGROUND VENDOR LIST CONDUCTING BUSINESS AT SANTEE LAKES WILL NOT BE ADMITTED ENTRANCE ONTO THE PROPERTY.
